Message from the Executive Secretary



The IIJ team is pleased to share with you our latest IIJ Newsletter (Winter/Spring 2019), providing an update on IIJ programs and activities since the end of a busy and productive 2018. 2019 continues that trend, with the IIJ team already on track to deliver nine programs since the start of the new year. Your ongoing support and collaboration remain integral to the IIJ's continued growth and sustainable impact.

IIJ programming in 2019 includes innovative programs across our eight IIJ Core Initiatives, plus three new workstreams directly linked to priority areas identified by our stakeholders: battlefield evidence, and the development of two new IIJ core courses. On battlefield evidence, the IIJ is leading a review of non-binding guiding principles for collecting, storing, analysing, and using battlefield evidence in criminal investigations and prosecutions, recently endorsed by the US Departments of Defense, Justice and State. The IIJ is also excited to announce two new core courses held twice a year, which will address respectively the key challenges of (i) investigating and prosecuting CT cases and (ii) using intelligence-derived evidence in criminal cases.

In November 2018, with the support of our Governing Board of Administrators, the IIJ began implementing a five-year Sustainability Strategy and a Strategic Communications and Outreach Strategy, setting a firm foundation for the IIJ's continued growth. The Strategic Communication and Outreach Strategy identifies a range of priority areas across five thematic areas: outreach and contact management, knowledge management, products and publications, establishing an IIJ Advisory Board, and launching an IIJ Alumni Network.

I am also pleased to share that the IIJ signed a long-term lease agreement with the University of Malta's Valletta Campus – reflective of our strong conviction that the IIJ's partnership with the Government of Malta and the University will strengthen our delivery of future programs and complement our sustainability efforts.

Finally, I draw your attention to the <u>registration link</u> for an upcoming fee-based course on **Mediterranean Security and the Rule of Law**. This exciting program – a joint project between the IIJ and the University of Malta's Mediterranean Academy of Diplomatic Studies (MEDAC) – will be held in Valletta on 18-20 June 2019, and will bring together MEDAC's expertise on the challenges and opportunities affecting Mediterranean security and the IIJ's expertise on how rule of law-based responses to security challenges can

bolster regional security. We welcome your participation in this timely program and ask that you help us to circulate the registration link widely to interested participants. Thank you for reading this newsletter and best wishes from the entire IIJ team.








IIJ Capacity Building Initiative: Prosecutors in the Southern Mediterranean January 23 - 24, 2019, Beirut, Lebanon




IIJ Core Curriculum: Using Intelligence to Generate Evidence for Terrorism Investigations and Prosecutions
